OPEN LETTER: Urgent Call to Reprioritise National Health Literacy and Consumer Engagement Strategies

As members of the Australian Self-Care Alliance, we write to express our deep concern about the apparent lack of progress in the development and implementation of the *National Health Literacy Strategy* and the *National Consumer Engagement Strategy for Health and Wellbeing*, outlined as immediate priorities for action in the *National Preventive Health Strategy 2021–2030*.

Both strategies are critical to strengthening Australia's preventive health system, and targeted consultation on their development began several years ago. The community and health sector have engaged in good faith throughout this process, and correspondence with the Prevention and Wellbeing Policy Section of the Department of Health and Aged Care indicated public consultation would progress in 2023. Yet there has been no action since 2022, and further delays risk undermining confidence in the Government's commitment to prevention and equity.

This delay is especially concerning as health literacy and meaningful consumer engagement have never been more important. Australia's health profile has changed significantly over the past 40 years and is now characterised by a high burden of chronic illness¹, and widening health inequities². Without a national strategy and implementation action plan, these inequities will deepen, and opportunities to reduce preventable disease and healthcare costs will be lost³. This highlights the urgent need to support consumers in self-care practices—building their capability to navigate the health system and participate in decision-making at both individual and system levels⁴.

We urge the Australian Government to **reprioritise and expedite the delivery of these strategies** to ensure:

 Stronger and purposeful partnerships with consumers in shaping policies, codesigning services, and ensuring preventive health initiatives reflect their lived experience.
